


AS A RESULT OF THIS I HAVE FOLLOWED HIS NUMEROUS COURT CASES OVER THE YEARS.

ONE OF THESE CASES WAS FOR A HEARING INTO THE ALLEGED HARASSMENT OF DR TEGWYN WILLIAMS WHO WAS A FORENSIC PSYCHIATRIST. DURING THIS TRIAL I ATTENDED CARDIFF MAGISTRATES COURT AS A FOLLOWER ONLY AND WAS SEATED IN THE PUBLIC GALLERY WITH A NUMBER OF OTHER FRIENDS.

AT SOME TIME DURING THE TRIAL MR KIRK WAS NOT IN COURT IN RELATION TO THE ALLEGED HARASSMENT.

I THEN SAW THE CROWN PROSECUTOR DAVID GARETH EVANS HAND THE DISTRICT JUDGE JOHN CHARLES VIA HIS CLERK A NOTE IN RELATION TO THE PROCEEDINGS.

I SAW JUDGE JOHN CHARLES READ AND HE SAID " I NEED TO ADD TO THIS". I THEN SAW HIM WRITING ON WHAT I BELIEVE TO BE THE SAME NOTE. HE THEN SAID " MR KIRK NEEDS TO SEE

I CANNOT RECALL WHAT HAPPENED WITH THE NOTE BUT I RECALL MEETING UP WITH MR KIRK A SHORT TIME LATER IN THE COURT FOYER.

ON 2ND MAY 2012, I ACCOMPANIED MR KIRK AT CARDIFF CROWN COURT AS A MCKENZIE FRIEND IN RELATION TO A TRIAL FOR A BREACH OF A RESTRAINING ORDER. THIS ORDER ORIGINATED FROM THE CASE PREVIOUSLY MENTIONED.

DURING THIS TRIAL THE SAME CROWN PROSECUTOR DAVID GARETH EVANS WAS PROSECUTING. DURING THE TRIAL MR KIRK REFERRED TO THE DOCUMENT PREVIOUSLY MENTIONED THAT I HAD SEEN IN THE MAGISTRATES COURT. AT THE END OF THE PROCEEDING ON DAY TWO OF THE TRIAL I APPROACHED DAVID EVANS AND STATED "THE DOCUMENT THAT MR KIRK WANTS IS THE ONE THAT JUDGE JONN CHARLES SCRIBBLED ON". HE REPLIED "I DON'T KNOW WHAT YOU ARE TALKING ABOUT." I SAID "4 OF US WITNESSED THAT DOCUMENT HANDED OVER AND SCRIBBLED ON."



